### Liability Waiver:

1. I accept all risks arising from these events and programs, even if arising from the negligence, gross negligence or negligent rescue by those associated in any way with the New Westminster and District Band Society events and programs I may be involved in, the venues at which these events and programs take place or by those organizing, officiating, or participating in these events and programs throughout the year, including their respective officers, directors, employees, agents, servants, volunteers and representatives (the "Releasees").
2. I understand that all applicable rules for participation must be followed and that sole responsibility for my personal safety remains with me, including my physical and emotional preparations and fitness to participate in all events and programs throughout the year.
3. I undertake and agree to remove myself from participation if I sense or observe any unusual hazard or unsafe condition or if, at any event or program, I feel unable or unfit to safely continue for any reason.
4. I give, a full release and waiver of liability and all claims that I, or my heirs, have, or may have in the future, against New Westminster and District Band Society from all liability for any loss damage, injury or expense that I may suffer as a result of my participation in any part or parts of the events or programs or my presence at any venue at which they may take place, due to any cause whatsoever including the forms of negligence set forth in paragraph 1 above or from any breach of contract or statutory duty or other duty of care including any duty of care owed under the relevant Occupier's Liability Act, on the part of the Releasees.

# New Westminster & District Band Society

## Conditions of Membership

Band fees are based on a 10 month period September to June.

Fees are:

- \$300 for Beginner Band
- \$250 for Jazz Band
- \$250 for Intermediate and/or Senior Band

Fees may be paid in full, or in half – year installments (i.e. \$125 due Sept. 30th 2010, \$125 due Jan 30 2011 by post-dated cheque.) If the member does not return for the second term, the post dated cheque can be reclaimed.

1. Members who pay their yearly dues in full by September 30th 2010, are eligible for a 10% discount. Total to be paid in full: \$225.00 for Jazz and/or Intermediate and/or Senior Band and \$270 for Beginner Band.
2. Band rehearsals begin the first Monday or Thursday following the Labour Day holiday in September.
  - Beginner Band: Mondays and Thursdays 6:00 pm - 7:00 pm
  - Intermediate Band: Thursdays 6:30 pm- 8:30pm
  - Jazz Band: Tuesday 7:00 pm- 9:00 pm
  - Senior Band: Mondays 6:30 pm - 8:30pm
3. Music folders must be present at every Senior rehearsal even if the member is not able to attend. Music is often shared and missing parts can be frustrating for the conductor and other members.
4. The loan of a band instrument to a member may be subject to a deposit. The parent or guardian is responsible for the instrument in case of loss or damage. Proof of insurance coverage will be required.
5. Musical instruments are subject to damage. In case of misuse, carelessness or accident, the band and the band society assumes no liability for any damage to or loss of instruments in the hands of band members and by the signature on the registration form, this fact is acknowledged.
6. Players make a commitment to their band. Regular attendance at all band practices and functions must be maintained. If you are going to be absent or late, please notify your conductor in advance.
7. All enquiries pertaining to ensemble placement should be discussed with the Band Directors.
8. Full support of all parents and guardians in fund-raising activities (chicken sales and Purdy's Christmas chocolate drive) is essential to ensure the success of the band. In lieu of participation in these efforts, a tax-deductable cash donation may be made to the band.
9. An **Annual General Meeting** is held in late **October** and the Executive of the Society is elected for the next year. **Attendance at this meeting is mandatory and each family must be represented by one adult member.**
